- THE DUTY TO PROTECT YOUR CONFIDENTIALITY. UNLESS THE LAW REQUIRES IT, THE FIRM AND ITS AGENTS WILL NOT DISCLOSE YOUR CONFIDENTIAL INFORMATION OR THE CONFIDENTIAL INFORMATION OF OTHER PARTIES.

STAT. § 452.01(5G) AS AN ADVERSE FACT THAT A PARTY INDICATES IS OF SUCH SIGNIFICANCE, OR THAT IS GENERALLY RECOGNIZED BY A COMPETENT LICENSEE AS BEING OF SUCH SIGNIFICANCE TO A REASONABLE PARTY, THAT IT AFFECTS OR WOULD AFFECT THE PARTY'S DECISION TO ENTER INTO A CONTRACT OR AGREEMENT CONCERNING A TRANSACTION OR AFFECTS OR WOULD AFFECT THE PARTY'S DECISION ABOUT THE TERMS OF SUCH A CONTRACT OR AGREEMENT.
